- This scholarship is designed for students who are committed to attend:
Paradise Valley Community College.
- Two-semester scholarship, RENEWABLE for an additional two semesters if student maintains a cumulative GPA of 2.5 or higher at PVCC. If eligible, this scholarship will award up to a maximum of 48 credit hours.
- Winners will be awarded \$1032.00 per semester, which covers full-time tuition of 12 credit hours. Students must enroll in at least 12 credits (or more) per semester. Student is responsible for funding beyond 12 credits.

DEADLINE: May 31, 2018

Eligibility Requirements and Checklist:

1. ___ 2018 graduate from an eligible public/private/charter high school (see list above)
2. ___ You must be a US citizen or permanent resident
3. ___ Cumulative High School GPA of 2.75 or higher
4. ___ Enroll full time completing a minimum of 12 credit hours each semester for the fall 2018 and spring 2019 semesters. with a GPA of 2.5 or higher
5. ___ Degree-seeking or planning to transfer to a 4-year college
6. ___ First generation college bound student is given strongest eligibility consideration (Parents did not complete a college degree)
7. ___ Complete/submit FAFSA (Free Application for Federal Student Aid) www.fafsa.ed.gov
8. ___ Demonstrate financial need, as determined by FAFSA. You will need a 2016 Tax return.
9. ___ All applicants must have filed and submitted the FAFSA application, enrolled and admitted to PVCC, placement testing, academic advising, and selection of 12 credits hour classes by the deadline on **May 31, 2018**. Failure to complete any of these steps prior to the deadline may disqualify the applicant. You must also check your "To Do List" in your PVCC Student Center to see if you have been selected for FAFSA verification issues. All financial aid issues must be completed in order to determine eligibility. The 2018-2019 FAFSA application opened on October 1, 2017.
